APPLICATION POLICIES: There is no charge to be on the waiting list. When a slip becomes available, the next person on the list will be called. If the available slip is bigger than necessary, you may decline the slip and opt to keep waiting. You will remain in the same spot on the list. If the available slip is the correct size for your boat and you decline the slip, you will be moved to the bottom of the list. (Correct size = Within 10' of your LOA) Once contacted regarding an open slip, you will have (2) days to provide your answer. If the Marina does not hear back within (2) days, the next person on the list will be called. Please check back every couple months to check on boat movement. If the Marina does not hear from you for over a year, you will be removed from the list.
